

# The Entrance Guide to Nursery Schools for 2022 (Noda City)

English Version

This guide is prepared based on the guide in Japanese.

Please check Japanese guide in case of items not mentioned in this guide.

## ○ Time of Entrance & Application Period

Time of Entrance to a Nursery School is the first of every month. Anyone can apply at any time, but an application varies according to the time of entrance. If you are returning to work after childcare leave, you can apply for admission in different months depending on the date you return to work (as indicated in the Japanese version of the admission guide. Please inform the staff at the counter if this applies to you).

## ○ Those who apply:

- Judging from the situation, you may be requested to wait to apply.
- You are requested to choose a nursery school by your own responsibility.  
(Even if you send the application to the only one nursery school, it 's hardly possible that your requirement will be accepted.)
- Please inform Child-care dept. without any delay if your child won't attend.
- If the submitted documents contain false information, you will not be able to enter. In addition, if it is found that there was false content after entering, you will be discharged.

## Recognition for benefits to children and infants

"The new childcare support system started in April 2015. As a result, in order to use licensed nursery schools, centers for early childhood education and care, small-scale child-care service, employer-provided childcare services, and kindergartens that have moved to the new system, it is necessary to obtain a new "Certification of Education and Childcare Benefits" for receiving education and childcare as follows;

This guide explains nursery schools, centers for early childhood education and care (daycare portion), small-scale child-care service, employer-provided childcare services (regional quota) that are available to those who are classified as "2nd Recognition" or "3rd Recognition".

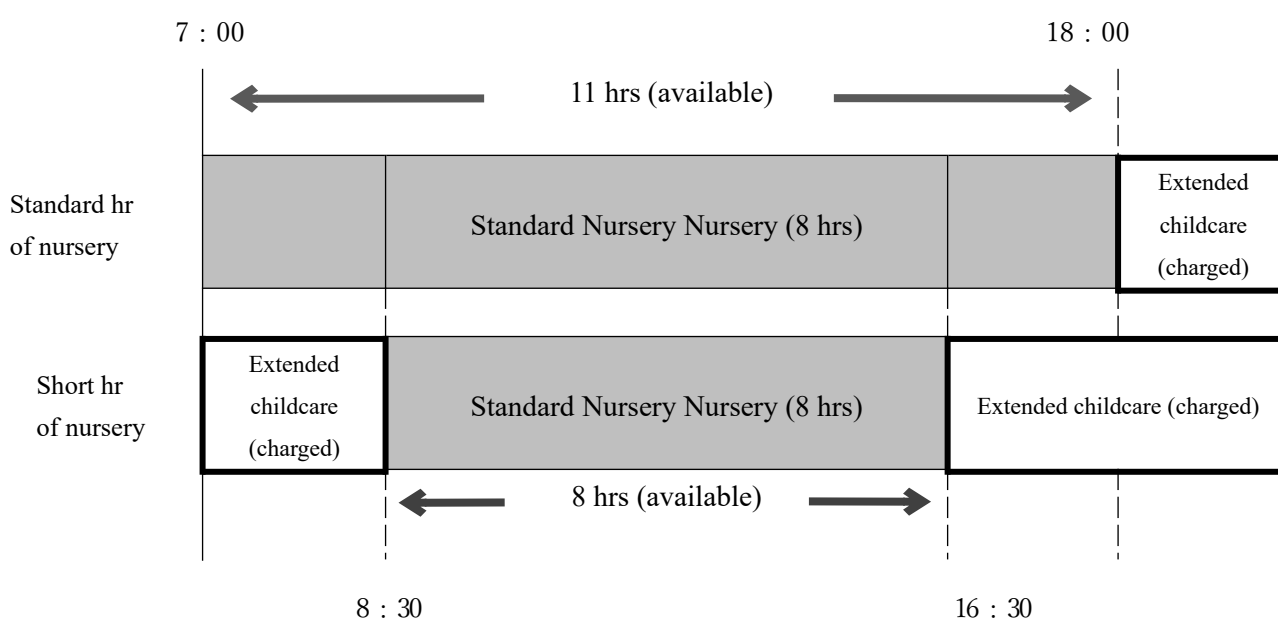

※ After the recognition, final adjustment will be taken by us.

● If the child is certified as needing childcare (No. 2 or No. 3), the child is divided into two categories according to the reason and the amount of childcare needed. "It is divided into two categories: "Standard Childcare Hours" and "Short Childcare Hours".

●Reasons that nursery is required;

The following conditions are applicable to the parents who apply to the 2nd- and the 3rd-recognition.

1. Working : More than **4 hrs/day and 16 days/month (more than 64 hrs/month)**.
2. Pregnant. Child Birth: Pregnant at present, right after childbirth.
3. Disease, Disabilities: Due to Parents' wound , ill, mentally or physically handicapped, parents can't take care of their child.
4. Nursing care: the case that you take of your parent living with or being hospitalized for a long time.
5. Disaster Restriction: In charge of repair works for earthquakes, Storm & flood, and other casualties.
6. Job-hunting: In case of continuous activities for job-hunting (incl. entrepreneurs).
7. Education: Students enrolled at school , vocational-training school.
8. Mal-treatment, DV by your spouse.
9. During Maternity Leave: **Infants who attend a nursery school are required to attend school.**
10. Others: In case that you can't take care of nursing.

## Flow of application procedure ※ Admission decisions are not on a first-come, first-served basis.

### [ Filling in an application form ]



- **Pay a visit and take a close look at your favorite nursery school.**
- Application forms are available at the Childcare department , Sekiyado Branch Office, each branch office and each nursery.

### [ Education and Childcare Benefit Certification and Application for Use of Nursery, etc. ]



- Recognition for benefit to children and nursery' and 'entrance to child care center' are accepted at the same time.
- The above documents are accepted at Child-care department , Sekiyado Branch Office, each branch office and each nursery.
- An application for job-hunting is not accepted at child-care center.  
**※If you have any concerns about your child's development, please contact us in advance so that we can arrange an interview and accept your application at the Childcare Department.**  
※We won't accept your application forms in case of lack of documents and/or incomplete documents.

### [ Certification of education and childcare benefits ]



- Recognition depends on the documents submitted to us. If recognized by us, information on Recognition for benefits to "Recognition for the benefit to children & infants" will be mailed to you (certificate on the benefit' will be issued upon request).
- **Even if you are certified as an education/childcare benefit, you may not be able to enter the desired nursery school.**

### [ Adjustment among applicants ]



- According to the necessity of your child or infant to enter, we make our decision.
- Your request is not always accepted on depending on the condition of vacancy at schools.  
**※ Adjustment for nursery schools listed in the application form is accepted.** If you'd like to submit the documents to other school, please do it by yourself.

### [ Result ]



- Result will be mailed to all those who applied even if you're qualified or not (not by phone).  
※"Result" will be mailed to those who are suspended and accepted .

◎Admission on Apr. \*\*\*\*\* Middle of Feb.(2nd application - middle of Mar.)

◎Admission after May\*\*\* 20th of previous month you want to enter.

- In the case of a pending application, monthly adjustments will be made until the shorter of "the period of approval for education and childcare benefits" or "entry in March 2022". Please note that you will need to reapply if you wish to enroll your child after the end of the approved period for education and childcare benefits or after April 2022.

### **【A Nursery Charge】** (Excludes parents of children already eligible for free childcare, such as those aged 3 and over)

- "A notice of nursery charge", "Nursery charge list", "Bank direct debit request form" along with "Notice of recognition" will be handed over to you through your nursery school. Please pay the fee through a bank by the end of every month (payment accepted at public nursery schools).
- ※ In the case of entrance on Apr. or Sep., a notice of a nursery charge & "Payment slop" will be handed over to those who enter the school around 20th of Apr. or Sep..

### **【Entrance Guidance】**

- Explanation-school activities, the belongings you should prepare in advance.  
There will be an interview for children, so please be sure to attend with your children.
- For 0-year-olds, a health certificate must be submitted after approval for admission.

### **【Commencement】**

- Commencement of a nursery school is the first day of every month.

### **【Trial Childcare】**

- Spending a whole day in an unfamiliar environment at the beginning of the visit can be very hard on your child. In order to ease the burden on your child, we will gradually extend the hours of your child's care, in consultation with the nursery.
- Trial childcare starts on 1st of every month and we will decide to terminate it. Please note that children will be coming home earlier during this period.
  - ※ Trial childcare is not applicable before the commencement of nursery school.
  - ※ Please note that we may not be able to offer Saturday or holiday childcare during this period.

## **Questions & Answers about a Nursery School**

### **Q1: Dose a nursery school keep medicines?**

**A1** : In principle, a public nursery school doesn't keep medicines in order to prevent accidents. We are not sure that a private nursery keeps a medicine. Please let us know if your child is chronic disease.

### **Q2: If a child applying for admission to the school has a food allergy, will the school be able to remove it?**

**A2** : Kitchens are equipped at public nursery schools. Cooks prepare lunch and snacks in accordance with the menus prepared by nutritionists. We always pay a special attention to food-allergy. But food-allergy may be caused by various foods. Please make sure that quick treatment may not be taken by us. Doctor's medical certificate and instructions are required in order to deal effectively with food-allergy, so your prompt information on allergy is required. Any private nursery schools take necessary measures against food-allergy, but their measures vary from private nursery schools to the schools.

### **Q3: Do you prepare lunches and snacks in accordance with religious precept?**

**A3** : Each school has its own policy (e.g. it is possible to remove pork and beef, but not all extracts). Please check with the school in advance. Please inform the staff when you apply.

Insufficient documents may cause the rejection of application and the disadvantage at the conference.
